



## GEMINI ACCOUNTING PROGRAM 2019 Federal PAYROLL TAX TABLE AND RATE CHANGES

Please do not change your payroll tax tables before you close **DECEMBER 2018**.

### **NOTE REGARDING THE SOURCE OF PAYROLL TAX INFORMATION**

Builder Incubator will make every effort to insure the information we provide is current and accurate. The source of information (the website and the document name) are included for your convenience. The governing body (both State and Federal) will occasionally relocate a source document, therefore the website link may no longer work. It is generally best to look up via document name.

### **IMPORTANT EMPLOYER PAYROLL NOTICES:**

1. If you have an employee who will exceed \$200,000 in wages in **2019**, you must withhold a **0.9% Additional Medicare Tax**. The additional Medicare Tax is only imposed on the employEE. Please contact Prosoft Support if you need assistance updating Payroll.

Information reflected in paragraphs 1 and 2, below, will be effective for wages paid in calendar year **2019**. To assist you with entering updated information, changes are shown in **Bold** font.

After you close DECEMBER 2018, update your Payroll tax tables for calendar year **2019** as shown in paragraphs 1 and 2, below, **before** you calculate your first CY 2019 payroll. In Gemini, *select each company to be updated, in turn, and update the tax tables for each individual Payroll company as follows:*



1. In each payroll company, select **PR | Payroll Setup | Deduction Tables**. Highlight each of the following tables, in turn, and click on **Change**. Update/correct table data as necessary. Select **OK** after each table is updated and verified and

**Close** after both have been updated. Then go to paragraph 2.
